AACCC-PG ONLINE COUNSELING SCHEME FOR SEAT ALLOTMENT IN ALL INDIA QUOTA-GOVT. / GOVT. AIDED / CENTRAL UNIVERSITIES/ NATIONAL INSTITUTES /DEEMED UNIVERSITIES AND INTERNAL SEATS OF BANARAS HINDU UNIVERSITY FOR THE ACADMEIC YEAR 2022-23

DISCLAIMER

- a) All Frequently Asked Questions (FAQs) in the scheme of AACCC-PG Counseling are mandatory and not optional. Candidates are advised to go through these important questions related to the counselling scheme before registering on the AACCC website (www.aaccc.gov.in)
- b) It is assumed that every participating candidate in AACCC-PG Counseling has read, agreed and accepted the Scheme and terms & conditions of the AACCC-PG counseling-2022.
- c) The candidate shall register online for AACCC-PG Counseling-2022 through the AACCC website (www.aaccc.gov.in). Application submitted through any other mode shall be summarily rejected. Further, Candidates are advised to fill the application/registration form on the AACCC website on their own.
- d) For the AACCC-PG counseling registration process, candidates are advised to use the same Mobile number/E-mail id used by them during registration for the AIAPGET-2022 examination on the NTA website.
- e) The candidate should ensure that all the information filled during the online application/registration form is correct and factual. The information provided by the candidates in the online application/registration form shall be treated as correct and self-certified. The AACCC, M/o Ayush shall not entertain, under any circumstances, any request to change/modify/edit/alter the information provided by the candidates. The dataentered by the candidate at the time of registration on the NTA portal will be pre-populated and used for counselling purposes.
- f) A candidate can submit the AACCC-PG counseling application/registration form only once. Any candidate who submitted more than one application/registration form shall be debarred from the AACCC-PG Counseling allotment process. Further, his/her candidature shall be cancelled, and further action as deemed appropriate by the AACCC, M/o Ayush shall be taken.

- g) Registration facility shall be available at the beginning of the 1st Round, 2nd Round & 3rd Round /Mop-up Round of AACCC-PG Counseling, as specified in the Counseling Schedule uploaded on the AACCC website. After that, the registration facility shall not be available under any circumstances. Further, any request (for any reason) for registration shall not be entertained after the closing of registration. There will be no fresh registration for the Stray Vacancy Round.
- h) If a candidate joins the allotted seat in the 2nd Round & wants to exit from the respective institution, then the Security Deposit will be forfeited. Further, if a candidate does not join the allotted seat or surrender the allotted/upgraded seat in the 3rd /Mop-up Round due to any unforeseen reason from the candidate's end, his/her Security Deposit will be forfeited. Furthermore, if a candidate does not join/surrender the allotted seat in the Stray Vacancy Round of AACCC-PG Counseling due to any unforeseen reason from the candidate's end, his/her Security Deposit will be forfeited.
- i) At the time of reporting at the allotted institutes, the Admission Authority will cancel the admission of the candidate who gives wrong information at the time of registration based on which a seat might be allotted. Further, the admission of those candidates who fail to produce the required documents at the time of admission (within the stipulated time) will also be cancelled.
- j) In case a candidate joins the allotted seat in the 2nd Round and thereafter wants to exit from the institute, in that case, he/she needs to withdraw/surrender from the respective institute three days prior to the commencement of registration for the 3rd/Mop-up Round of AACCC-PG counseling, with forfeiture of security money to avoid disqualifying from further AYUSH-PG counseling. If the candidate fails to do so, he/she shall be ineligible for further AYUSH-PG counseling (Central/State/UT/Central Pool Quota).
- k) The AIQ (Govt. /Govt. Aided /CU/NI) seats that remain vacant after the 2nd Round will be converted during the 3rd/Mop-up Round of counselling as per the algorithm placed at **Chapter-4** only if the reserved seats are not opted by any candidates/non- availability of candidates of that particular category in the 3rd/Mop-up Round. Further, unreserved category candidates cannot claim the reserved seats shown to them as a virtual vacancy if the same seat is opted by the candidate of that particular category.

- 1) Once a candidate is allotted a seat in the 3rd/Mop-up Round or Stray Vacancy Round (conducted by the AACCC, M/o Ayush through online mode) of AACCC-PG counseling, he/she will not be eligible for exiting from the admitted/allotted seat. If the candidate does so, he/she will not be eligible for further AYUSH-PG Counseling (Central/State/UT/ Central Pool Quota), and the security money of such candidates will be forfeited. Further, a list of such ineligible candidates will be circulated to concerned State/UTs counseling authorities, National Institutes/ Central Universities/ Deemed Universities to prohibit them from participating in any other counseling.
- m) Candidate may kindly note that merely registering for AACCC-PG Counseling-2022 does not confer automatic rights to secure a Post-Graduate (MD/MS) seat. The AACCC, M/o Ayush does not allot any seats on nomination basis or manually. The selection and admission in any of ASU & H Institutions, recognized for running undergraduate courses as per NCISM Act, 2020 & NCH Act, 2020, is subject to the fulfilment of the merit, admission criteria, eligibility as prescribed by the respective Universities, ASU&H institutions, NCISM, NCH, State & Central Government.
- n) The information regarding fee structure/stipend/bond amount/rendering of service in rural/tribal areas/other conditions etc., has been provided by concerned Ayurveda /Siddha/ Unani/Homoeopathy Colleges. The AACCC, M/o Ayush shall not take responsibility regarding the information provided by the participating institutes, including Fees/ Bond/ Mode of Payment or any typographical error/ data. Hence, Candidates are advised to visit the College website or contact the College Authorities directly for any query regarding the above information before filling choices. Once locked, the choices cannot be modified, and any request regarding tinkering choices will not be entertained by AACCC, M/o Ayush.
- o) Candidates are advised to confirm the fee structure/ any other additional fee from the colleges especially Deemed Universities, before filling up the choices. Some colleges/institutes might have a high fee structure; therefore, accurate information about the fee should be made beforehand. The AACCC, M/o Ayush takes no responsibility for the fee structure of the colleges and will not entertain any request or complaint regarding the Fee Structure.
- p) Counseling for All India Quota PG (MD/MS) seats of Private ASU & H Institutes



- (other than Deemed Universities) will be conducted by the counseling authority of the respective State/UT Government for the academic session 2022-23.
- q) For Admission in All India Quota PG (MD/MS) seats of Private ASU & H Institutes/colleges (other than Deemed Universities), the candidates are required to contact the concerned State Government-Counseling/Admission Authority.
- r) No communication will be directly sent to the candidate (s). They are advised to be in touch with the AACCC website (www.aaccc.gov.in) regularly for any updates on Schedule / latest updates / Results / Notices / News & Events regarding AACCC-PG counseling.
- s) The AACCC, M/o Ayush will not entertain the admission made through offline mode by the college under any circumstances. Therefore, candidates are advised to ask for an online generated 'Provisional Admission Letter' at the time of physical reporting to ensure that the college has admitted them through online mode.
- t) There shall not be any offline admission or admission without counseling, and AACCC, M/o Ayush, shall not approve any admissions in contravention of this.
- u) All admissions and resignations (if allowed) will be made through online mode only; no offline admissions/ resignation of the seat is permitted.
- v) Some institutes reserve all their seats of permitted intake capacity for minority categories Muslim Minority (MM) etc. Only students of that respective category are eligible for admission to such institutes.
- w) The AACCC, M/o Ayush has no role in Counselling for Central Pool Quota seats.
- x) The role of AACCC, M/o Ayush is limited to allotment of AIQ seats to the participating candidates, as per their merit and choices, which starts only after receiving the list/data/Information of successful candidates from the National Testing Agency, i.e. the AIAPGET-2022 examination conducting body.
- y) The security amount will be refunded to the bank account provided by the candidate at the time of registration on the AACCC-PG portal.

CHAPTER-1 INTRODUCTION

Ayush Admissions Central Counseling Committee (AACCC) of the Ministry of Ayush, Govt. of India, New Delhi is conducting Online Counseling for the allotment of AIQ-Post Graduate (MD/MS) seats of Ayurveda/Siddha/Unani/Homoeopathy under Govt. /Govt. Aided/Central Universities/National Institutes/Deemed Universities (100%) and Institutional seats of BHU to AIAPGET qualified eligible candidates since 2019. The allotment of seats to the candidates is made based on the AIAPGET 2022, Examination conducted by National Testing Agency (NTA).

The AIQ-PG seats under AACCC-PG Counselling are as follows *:

- i. 15% All India Quota PG (MD/MS) Seats of Govt./Govt. aided institute of all States/UTs
- ii. 100% PG (AIQ and Institutional Quota) Ayurveda Seats of BHU, Varanasi, Uttar Pradesh
- iii. 100% PG (Ayurved) seats of ITRA, Jamnagar, Gujarat(except nominated seats)
- iv. 50% PG (Ayurved) seats of NIA, Jaipur, Rajasthan (except nominated seats)
- v. 100% PG (Homoeopathy) seats of NIH, Kolkata, West Bengal (except nominated seats)
- vi. 100% PG (Homoeopathy) seats of NHRIMH, Kottayam, Kerala
- vii. 100% PG (Unani) seats of NIUM, Bangalore, Karnataka (except nominated seats)
- viii. 100% PG (Unani) seats of NRIUMSD, Hyderabad, Telangana (except nominated seats)
- ix. 100% PG (Unani) seats of RRIUM, Srinagar, Kashmir (except nominated seats)
- x. 50% PG (Unani) seats of AMU, Aligarh, Uttar Pradesh.
- xi. 50% PG (Siddha) seats of NIS, Chennai, Tamil Nadu.
- xii. 100% PG-AU&H seats of all Deemed Universities.

The role of AACCC, M/o Ayush is limited to the allotment of seats to the participating candidates, as per their merit and choice, which starts only after receiving the list/data/Information of qualified candidates from the National Testing Agency.

CHAPTER-2 COUNSELING TYPES & ROUNDS

15% AIQ-GOVT./GOVT.AIDED

- ➤ All candidates qualified for the AIAPGET 2022 Examination are eligible (except J&K).
- The AACCC, M/o Ayush will conduct four rounds of counseling for admission in 15% All India Quota seats under Govt./Govt-Aided colleges/institutes through online mode: i.e. Round 1, Round 2, 3rd/Mop-up Round and Stray Vacancy Round.
- ➤ The Stray Vacancy round will be conducted for admission in vacant seats (non-reporting/non-joining) after completion of the 3rd /Mop-up Round.
- ➤ No seats will be reverted to the participating institutes after completing all rounds of AACCC-PG counseling.

AIQ-CENTRAL UNIVERSITIES / NATIONAL INSTITUTES

- ➤ All candidates qualified for the AIAPGET 2022 Examination are eligible (except J&K).
- ➤ The AACCC, M/o Ayush will conduct four rounds of counseling for admission in seats under Central Universities and National Institutes through online mode: i.e. Round 1, Round 2, 3rd/Mop- Up Round and Stray Vacancy Round.
- The Stray Vacancy round will be conducted for admission in vacant seats (non-reporting/non-joining) after completion of the 3rd /Mop-up Round.
- ➤ No seats will be reverted to the participating institutes after completing all rounds of AACCC-PG counseling.

100% DEEMED UNIVERSITY

- ➤ All eligible candidates (including J&K) who have qualified for the AIAPGET 2022 and registered in AACCC-PG portal are eligible to participate all Rounds of AACCC-PG counseling-2022.
- ➤ There will be four rounds of counseling, i.e. Round 1, Round 2, 3rd/ Mop-Up Round and Stray Vacancy Round.
- ➤ Out of the four rounds, three rounds will be conducted online by the AACCC, M/o Ayush, i.e. Round 1, Round 2 and 3rd /Mop-Up Round.
- ➤ The Stray Vacancy round shall be conducted by the respective Deemed Universities, for which the AACCC, M/o Ayush will forward the list of registered eligible candidates to the respective Deemed Universities. Only candidates registered in the AACCC-PG counseling are eligible for the Stray Vacancy Round, conducted by Deemed Universities.
- ➤ All PG seats of Deemed Universities are domicile free and un-reserved, i.e. reservation policy of Central Govt. is not applicable.



Distribution of PG Seats

- > 50% Seats of Ayurveda PG courses under BHU are deemed to be All India Quota, for which candidates from across the country shall be eligible.
- > 50% of Institutional quota seats of Ayurveda PG courses under BHU are reserved for candidates who have completed their undergraduate degree (BAMS) course from BHU.

Roster:

➤ The roster on the 50% AIQ-PG seats and 50% Institutional Quota-PG seats of BHU shall be applied by the AACCC, M/o Ayush.

Eligibility Condition for BHU Institutional seats:

The Institutional quota is allocated for only those students who have passed the BAMS fourth professional examination held in 2021 in Faculty of Ayurveda, IMS, BHU and completed the internship in 2022 (i.e., 31st December 2022) and provided the candidate has appeared and qualified in the AIAPGET-2022 examination. (BHU provides the eligibility condition for Institutional quota. AACCC, M/o Ayush has no role to play in this regard)

CHAPTER-4 RESERVATION POLICY

Reservation Policy of the Central Government in All India Quota seats under Govt. / Govt. Aided / National Institutes/ Central Universities is as follows:

- ➤ S.C.- 15%
- ➤ S.T.- 7.5%
- ➤ OBC-NCL- 27% (Non-Creamy Layer as per the current updated central list of OBCs http://www.ncbc.nic.in; OBC candidates present in the state list but **not** covered in the Central list of OBCs are **NOT** eligible to claim for reservation under OBC-NCL.
- EN-EWS- 10% (as per the prevailing norms and/or notifications of the Govt. of India.)
- PwBD- 5% (Horizontal Reservation, i.e., **5%** in each of OPEN, GEN-EWS, OBC-NCL, SC, and ST category seats)

Candidates belonging to the creamy layer of OBC are NOT entitled to reservation. Such candidates are treated as belonging to the General (GEN), i.e. unreserved category, and they will be eligible only for the OPEN seats – the seats for which all candidates are eligible.

The benefit of GEN-EWS reservation will be given only to those General category candidates who satisfy the conditions specified by the directives issued by the Ministry of Social Justice and Empowerment from time to time.

Candidates with at least 40% impairment, irrespective of the type of disability, i.e., locomotor, visual or SEVERE dyslexic, shall be eligible for the benefits of the PwBD category. Further, Leprosycured candidates who are otherwise fit to pursue the courses are also included in this category.

The Certificate in the prescribed format, issued by the competent authority, is only accepted at the time of admission. If the candidate fails to produce the Caste and PwD/EWS certificate in the prescribed format, if applicable, at the allotted ASU & H College, then he/she will not be permitted to take admission, and his/her category will be changed in next round, if otherwise eligible. Further, Candidates are requested to carefully read AIAPGET, 2022 Bulletin/Prospectus in detail, regarding Caste, EWS and PwD Reservation/Certificate (see the link: https://aiapget.nta.nic.in/information-bulletin/).

The format of the 'Certificate of Disability' is attached in Annexure-I, and the list of Designated disability Centres is enclosed as Annexure-II

The AIQ (Govt. /Govt. Aided /CU/NI) seats that remain vacant after the 2nd Round will be converted during the 3rd /Mop-up Round of counselling as per the following conversion algorithm, only if the reserved seat is not opted by any candidate/non-availability of candidate of that particular category in 3rd/Mop-up Round. Further, candidates belonging to the unreserved category cannot claim the reserved seats shown to them as a virtual vacancy if the same seat is opted by the candidate of that particular category.

CHAPTER-5 REGISTRATION & COUNSELING PROCESS

IMPORTANT

- ❖ AIAPGET-2022 Qualified candidates are required to register on the AACCC website (www.aaccc.gov.in) to participate in the AACCC-PG counseling.
- ❖ Candidates are advised to use same e-mail Address and Mobile Number for registration on the AACCC-PG portal for Counseling which was provided to NTA during Registration of AIAPGET- 2022 Examination.
- ❖ All the information/communication will be sent by AACCC, Ministry of Ayush on the registered E-mail address or registered Mobile Number only.
- ❖ Any request regarding change of registered mobile number or email address shall not been entertained by the AACCC, Ministry of Ayush.
- ❖ Candidates are advised to use a Laptop or Computer with the latest registered version of Chrome/Internet Explorer/Firefox/Windows/IOS during the Registration and Choice-Filling process to avoid any technical complications.
- ❖ Be extremely careful while registering in the AACCC-PG Portal. Your allotment will be as per the information provided at the time of registration.
- Candidates are advised to download 'Sandes app' for getting OTP on your registered phone number during registration for AACCC-PG counseling.

ROUND-1

Eligibility: Only AIAPGET-2022 qualified candidates will be eligible to apply for the AACCC-PG counseling.

Process:

- Step 1: Registration for AACCC-PG Counseling.
- Step 2: Payment of Counselling Fee (Non-Refundable Registration Fee + Security Deposit Money)
- Step 3: Choice filling and locking
- Step 4: Release of Seat allotment list (Result Publication)
- Step 5: Reporting to the allotted college.
- Step 6: Submission of willingness for up-gradation of the seat in the 2nd Round

ROUND-2

Eligibility:

- a) AIAPGET-2022 qualified candidates who have not registered in Round 1
- b) Candidates registered for the 1st Round and were not allotted seats.
- c) Candidates who have opted for free exit in the 1st Round.
- d) Candidates joined the allotted seat in the 1st Round and submitted willingness for up-gradation in the 2nd Round.

Process:

- Step 1: Registration for AACCC-PG Counseling. (The candidates who participated in 1st Round need not be registered again).
- Step 2: Payment of Counselling Fee includes Non-Refundable Registration Fee + Security Money (Need not pay by the candidates, those who already paid the counseling fee at time of registration for 1st Round)
- Step 3: Choice filling and locking
- Step 4: Release of Seat allotment list (Result Publication)
- Step 5: Reporting to the allotted college.
- Step 6: Submission of willingness for up-gradation of the seat in the 3rd /Mop-up Round

ROUND-3/MOP UP ROUND

Eligibility

- a) AIAPGET-2022 qualified candidates who have not registered in Round 1 & Round 2.
- b) Candidates who have already registered but were not allotted seats in the 1st Round & 2nd Round. (No need to register again.)
- c) Candidates joined in the 1st Round allotted seat and submitted willingness for up-gradation, but did not participate in the 2nd Round of counseling.
- d) Candidates joined the allotted seat in the 2nd Round and submitted willingness for up-gradation in the 3rd Round.
- e) Candidates who leave/resign the allotted seat in the 2nd Round, with forfeiture of Security money, three days before the commencement of the registration for 3rd Round, can participate with payment of complete fees.

Process

Ministry of Ayush

- Step 1: Registration for AACCC-PG Counseling. (Those candidates who participated in 1st Round/2nd Round need not be registered again)
- Step 2: Payment of Counselling Fee includes Non-Refundable Registration Fee + Security Money (No Need to pay by those candidates who have already paid the counseling fee at the time of registration for 1st Round /2nd Round)
- Step 3: Choice filling and locking
- Step 4: Release of Seat allotment list (Result Publication)
- Step 5: Reporting to the allotted college.

IMPORTANT

It is mandatory for the candidates to take admission on their upgraded seats in the $3^{\rm rd}$ /Mop-Up round from Round 1 &2 admitted seats. Such candidates, if not joined in the upgraded seats, will become ineligible for any further AYUSH-PG counseling (Central /State /UT/ Central Pool Quota.) and their security money will be forfeited.

STRAY VACANCY ROUND FOR GOVT./GOVT. AIDED COLLEGES/CU/NI

The seats remain vacant (not joined/withdrawn) after the 3rd/Mop-up Round of AACCC-PG Counseling of Govt./Govt. Aided colleges/CU/NI will continue to be filled through the online Stray Vacancy Round conducted by the AACCC, M/o Ayush.

Eligibility for participation:

All registered candidates who have not been admitted to any of the seats through AACCC-PG counseling or counseling conducted by State/UTs are eligible for Stray Vacancy Round.

Process

- ➤ There is no Fresh Registration in Stray Vacancy Round.
- ➤ Candidates must submit a willingness in the AACCC-PG portal to participate in the Stray Vacancy Round with an undertaking that they are not holding any PG (ASU&H) seats allotted through AACCC-PG counseling or counseling conducted by State/UTs.
- > Option for choice filling is available in the Stray Vacancy Round.
- ➤ No up-gradation is available from the 3rd/ Mop-up Round to the Stray Vacancy Round.

STRAY VACANCY ROUND FOR DEEMED UNIVERSITY

- ➤ For seat allotment under Deemed Universities, the Stray Vacancy Round will be conducted by the respective Deemed Universities at their own level.
- AACCC, M/o Ayush will send a list of eligible registered candidates to Deemed Universities, which is to be exercised strictly in order of merit in the Stray Vacancy Round.
- ➤ The seats are domicile-free, and only registered candidates of AACCC-PG counseling are eligible for admission.

IMPORTANT

Further, a list of ineligible candidates will also be circulated to concerned State/UT counseling authorities, National Institutes/ Central Universities/Deemed Universities for prohibiting them to participate in any other AYUSH-PG counseling (Central/State/UT/Central Pool Quota).

Frequently Asked Questions (FAQ's)

Q.No.1.When will the AACCC-PG online seat allotment process for this Academic Year start?

Ans: The Online seat allotment process will start as per the Schedule of the AACCC-PG Counseling for the Academic Year 2022-23. Please See the Schedule and notices uploaded on the AACCC website (www.aaccc.gov.in) from time to time.

Q.No.2. How do you register on the AACCC-PG website/Portal, and how do you fill in Choices?

Ans: Candidates must log on to the website (www.aaccc.gov.in) to register and fill in choices. Please read and understand the Information Bulletin, counseling scheme/FAQs-2022 carefully before the start of online registration & choice filling. Further, candidates are advised to make a tentative list according to their preference of colleges/Courses after going through the seat matrix uploaded on the website before choice filling/locking.

IMPORTANT

The registration facility will be available at the beginning of the 1st Round, 2nd Round and 3rd/Mop-up Round. There will be no fresh registration for Stray Vacancy Round conducted by AACCC, M/o Ayush

Q. No. 3. How and when do I have to make the payment for AACCC-PG counseling?

Ans: After registration, the payment page appears automatically. Candidates can only make online payments by Net Banking /Credit card/ Debit card. After the successful completion of payment, the candidate can proceed with choice filling.

Q.No.4. Do I have to report to any counseling center for registration or choice filling?

Ans: No, Online registration and choice filling can be done from a place of convenience (including from home) using a laptop/computer with an uninterrupted internet facility.

Q.No.5. Do I require any documents to get registered online?

Ans: Since it is an online allotment (Counseling) process, no documents are required. However, you need to fill up the similar information you gave at the time of registration for the AIAPGET-2022 examination on the NTA website and upload a legible scanned copy of the Cancelled Cheque/Bank Passbook/ Bank e-Statement (having account details).

IMPORTANT

During registration on the AACCC portal, you have to fill in exactly the same credentials (spelling, numbers, etc) which you have already submitted at the time of registration for the AIAPGET-2022 examination on the NTA website.

Q.No.6. How do I get the password for logging in?

Ans: During the process of online registration, you have to create your unique password. Candidates are advised to keep the password confidential till the end of the counseling

process. The candidate can change the password in the future as per convenience. Sharing of password can result in its misuse by somebody else, leading to even exclusion of genuine candidates from the online allotment process. (Please see the password policy uploaded in the AACCC-PG portal)

Q.No.7. Difficulty in login; what may be the problem(s)?

Ans: Follow the instructions about the use of the browser (latest registered version of Chrome/Internet Explorer/Firefox/Windows/IOS), use similar spellings and the similar format of the date as in the online application form submitted at the time of registration of AIAPGET-2022 examination on the NTA website. The internet connection should be uninterrupted. If an interruption in the internet connection occurs, the IP address being monitored will change, and the session expired message will be displayed.

Q.No.8. I have difficulty in creating a Password; what may be the problem(s)?

Ans: Create a password as per the password policy. Please use the internet browser as suggested above (**Q.No.7**), as it is difficult to log in from other browsers. While creating a password, use the 'Shift' key instead of the 'Caps Lock' key.

Q.No.9. If I forgot the password, how to retrieve it?

Ans: To retrieve the forgotten password, the software system facilitates the following process:

Reset password using a reset link via registered E-mail

Candidate has to enter their AIAPGET-2022 examination Roll No. If entered data (Roll No.) matches with the backend database, then the system will send a reset password link to the registered email-id. After clicking the received link in the mail-inbox, candidates must follow the online instructions to reset the New Password.

Reset password using an OTP via SMS

Candidate has to enter their AIAPGET-2022 examination Roll No. If entered data (Roll No.) matches with the backend database, then the system will send a verification code through SMS to the registered mobile no. Candidates are required to enter a verification code, and if the verification code matches with the database, the system will prompt resetting New Password.

IMPORTANT

It is strongly recommended that the OTP sent to the applicant for any activity like reset password etc. must not be shared with anyone. This OTP is confidential and to be used by the applicant only. Neither AACCC, M/o Ayush nor NIC will be responsible for violation or misuse of the password/OTP.

Q.No.10. When I try to log in for choice filling, it says wrong roll number/password; what may be the problem(s)?

Ans: This can happen if the roll number or password typed is incorrect. Password is case sensitive; therefore, use exactly the same password created earlier. In case the password is forgotten, try to retrieve it using the process mentioned in **Q.No.9** above

Q.No.11. Is there any restriction for filling up the number of choices of Institutions and courses?

Ans: You can give as many choices as you wish during online choice filling. However, the

candidate must fill in the choices of colleges/courses in the order of his/her preference (higher to lower). There will be common software for Govt./ Govt. Aided/ Deemed/ National Institutes/Central Universities for filling up choices.

Q.No.12. Can I know the seat I will likely get at my rank?

Ans: You can have some idea from the following:

Please log on to the AACCC- website (www.aaccc.gov.in). Click on the PG Counseling tab on the home page, and go to Archives under News & Events section; you will get details of Course and category wise Opening and Closing rank of admission in ASU&H-PG courses in the previous year, i.e., A.Y-2021-22 (Excluding data of candidates admitted in Stray vacancy round of Deemed University). This will only be indicative, and the admission pattern for the current A.Y may vary as per the availability of PG seats in ASU&H courses.

Q.No.13. How do I know about the availability of seats in participating institutes during 1st Round of AACCC-PG counseling?

Ans. AACCC, M/o Ayush will upload the data of available seats during each round of counseling on the AACCC-PG portal. Accordingly, candidates can submit their choices for each Round of AACCC-PG counseling.

Q.No.14. Is filling up and lock choices necessary to get the seat allotted? Or will I be allotted a seat automatically from leftover seats?

Ans: After online registration, you must fill in the choices of colleges/courses in order of your preference (higher to lower) and lock it before the server time. The submitted/ filled choices can be modified before locking. If candidates do not lock the choices submitted by them, it will be automatically locked as per schedule/ Server time. You will not be allotted any seats if you don't fill in choices even after registering in the AACCC portal. Candidates can download/print out the locked choices for future reference.

Q.No.15. Is it necessary to download the duly filled registration form for AACCC-PG Counseling from the AACCC- portal?

Ans: Yes, it is necessary to download the duly filled registration form for AACCC-PG Counseling from the AACCC- PG portal. Some universities instruct the candidates to submit the same to complete the admission process.

Q.No.16. Can I modify my choices during the choice submission period for counseling?

Ans: Yes, you can modify, add or delete your choices during the choice Filling/Locking period. Further, you are advised to do the same before locking the choices by yourself or the System as per schedule/ Server time.

Q.No.17. What will happen to my choices if I have not locked my choices before the time specified in the counseling schedule on the last date of choice locking?

Ans: The choices submitted and saved by you will be locked automatically on the last date of choice filling/locking period as per server time.

Q.No.18. How can I get a printout of my choices?

Ans: Candidates are requested to login to the AACCC portal and take a printout of their choices that they have locked during the choice filling /Locking period or after the specified time of the last date of choice locking.

Q.No.19. Is it possible to modify/edit my choices after the choice locking?

Ans: Once lock the choices, it is impossible to unlock the same, even from the AACCC end. Hence, the candidates are advised to verify all choices before locking in.

IMPORTANT

Don't wait till the last minute to Register and fill in choices on the AACCC-PG portal. Please go through your selected/submitted choices before locking, as once you lock the choices it cannot be modified or changed even if you have made a mistake. It may result in the allotment of a seat which you never wanted. (Please note that the choices once locked cannot be unlocked even from the AACCC end)

Q.No.20. What about the Stipend/fee structure/bond amount/rendering of service in rural/ tribal areas/other conditions?

Ans: Stipend/Fee structure/bond amount/rendering of service in rural areas / tribal areas /other conditions, etc., may vary from State to State and Institute to Institute. The allotment made through the online Counseling process will be firm and final. Therefore, the candidates should be aware of these points before opting for a seat of ASU & H Colleges. The AACCC, M/o Ayush shall neither be responsible nor entertain any cases on the above grounds.

The information received from the participating ASU&H-PG Colleges has been made available on the Counseling website. However, before filling the choices, candidates are advised to visit the College website or contact the College Authorities directly for any query regarding the above information. The Choices, once locked, cannot be modified, and any request to the AACCC, M/o Ayush regarding tinkering of choices will not be entertained.

IMPORTANT

AACCC, M/o Ayush has no role in the fixation of Fee Structure/ Stipend of ASU & H Colleges. Therefore, the AACCC, M/o Ayush will not entertain any request or complaint regarding Fee Structure/ Stipend.

Q.No.21. How much time will be given to join the allotted course/Institute?

Ans: Candidates who have been allotted seats must join the allotted College/Course within the stipulated time from the date of allotment as mentioned in the counseling schedule. However, candidates are advised to join as early as possible and not to wait till the last day of joining due to the different holiday/working hours schedules in various ASU & H Colleges. Some colleges may take 2 to 3 days to complete the admission formalities.

Q.No.22.Whether my admission is valid if the college admitted me to the allotted seat through offline mode?

Ans: No, the AACCC, M/o Ayush will not approve the admission made through offline mode by the college under any circumstances. Therefore, candidates are advised to ask for an online generated 'Provisional Admission Letter' through the AACCC portal at the time of admission to ensure that the college has admitted him/her through online mode.

Q.No.23. What will be the fate of the seat at which the college makes offline admission?

Ans: If a candidate is admitted through offline mode at the allotted seat, the seat occupancy will be shown as 'vacant' in the PG-admitted/reported list in the AACCC-Portal; further, this vacant seat will be filled in the next round of AACCC-PG counseling. Therefore, the offline admitted candidate will lose his/her allotted seat in the respective round of the AACCC-PG counseling.

Q.No.24. What documents are required at the time of joining in allotted ASU&H College?

Ans: Original documents (along with attested photocopies of documents) required at the time of joining in allotted ASU&H College are as mentioned below:

- i. Provisional Allotment Letter issued by AACCC, M/o Ayush
- ii. AIAPGET-2022 Admit Card issued by NTA
- iii. AIAPGET-2022 Result/Rank Letter issued by NTA
- iv. 10th pass certificate
- v. Mark Sheet of Higher Secondary.
- vi. Mark Sheets of BAMS/BUMS/BHMS/BSMS 1st, 2nd & 3rd Professional Examinations or 1st, 2nd, 3rd & 4th Professional Examinations (as applicable).
- vii. BAMS/BUMS/BHMS/BSMS Degree Certificate or Provisional Degree Certificate. (undertaking from candidate to submit Original Degree Certificate before the cutoff date of admission to ASU&H-PG courses, decided by NCISM/NCH for the A.Y 2022-23)
- viii. Twelve months Compulsory Rotating Internship Completion Certificate/Certificate from the Head of the Institution or College that the candidate completed the Internship on or before 31st December 2022.
- ix. Permanent/Provisional Registration Certificate issued by NCISM/ NCH/ CCIM/ CCH/State Ayurveda /Siddha /Unani /Homoeopathy Board. (undertaking from candidate to submit Permanent Registration Certificate before the cut-off date of admission to ASU&H-PG courses, decided by NCISM/NCH for the A.Y 2022-23)
- x. Date of Birth Certificate. [if the 10th Certificate does not bear the same.]
- xi. Candidates must carry one of the identification proofs (ID Proof) to the allotted college at the time of admission (i.e. PAN Card, Driving License, Voter ID, Passport or Aadhar Card).
- xii. Medical Certificate issued by Registered Medical Practitioner in the prescribed format is attached as Annexure-VI.
- xiii. The Candidate should also bring the following certificate, if applicable:

a)
Disability Certificate issued from a duly constituted and authorized Medical Board for 21 Benchmark Disabilities as per the Rights of Persons with Disability Act, 2016, will be accepted. The format of the Certificate of Disability is attached as **ANNEXURE-I.**. No other PwD certificate issued by any other Authorities/ Hospital will be accepted.

(The qualified candidates with Benchmark Disability (PwBD)-should get themselves certified at one of the Disability Assessment Boards, constituted in various States/UTs. The list of Authorized designated Centers that will issue Disability Certificates as per 21 Benchmark Disabilities given under RPWD Act-2016 is attached as **ANNEXURE-II**)

- b) The SC/ST Certificate, issued by the competent authority, should be in English or Hindi. Sub-caste should be mentioned in the certificate. The certificate should be as per the prescribed format of the Government of India (ANNEXURE-III).
- oBC-NCL certificate issued by the Competent Authority (issued on or after 1 January 2022) as per the prescribed format of the Government of India. The sub-caste in the OBC-NCL certificate should tally with the updated Central List of OBC available on the National Commission for Backward Classes (NCBC), Government of India website www.ncbc.nic.in The OBC-NCL certificate format is attached as ANNEXURE-IV.
- d) Economically Weaker Section (GEN-EWS) certificate issued on or after 1 January 2022 by the Competent Authority shall be accepted. (ANNEXURE-V)

IMPORTANT

Candidates without original certificates/documents shall not be allowed to take admission to the allotted ASU&H College. Candidates who have submitted their original documents with any other Institute /College /University and come for admission with a certificate/undertaking stating that "original certificates are deposited with the Institute/College/University" shall not be allowed to take admission in allotted ASU & H College.

Q. No 25. Should I submit any other certificate (e.g. valid Caste certificate) to complete the admission process?

Ans. Candidates are requested to confirm with the allotted Colleges regarding any requirement of certificates other than that mentioned in **FAQ No.24**. If so, the candidates are instructed to bring such required certificates (e.g. Caste Valid certificate) at the time of reporting at the allotted seats.

Q.No.26. In which format should I submit the certificates; if I do not submit certificates in the prescribed format, what will happen to my allotted seat?

Ans. Candidates are requested to submit the relevant certificates issued by the competent authority in the prescribed format of the Government of India. If the candidate fails to

produce the Caste and PwBD/GEN-EWS certificate in the prescribed format, if applicable, at the allotted ASU & H College, then he/she will not be permitted to take admission, and his/her category will be changed for seat allotment in next round, if otherwise eligible.

Q.No.27. From where will I get the details of the reservation and certificates?

Ans. You must read the AIAPGET-2022 Bulletin/Prospectus carefully regarding Caste, GEN-EWS and PwBD Reservation/Certificate. Please click on the link to see the AIAPGET-2022 Information Bulletin. (https://aiapget.nta.nic.in/information-bulletin/)

Q.No.28. Is there any upper age limit for the candidates seeking admission to ASU &H-PG courses for the academic year 2022-23?

Ans: There is no upper age limit for admission in ASU & H-PG courses.

Q.No.29. What are the instructions regarding GEN-EWS, OBC, SC, ST & PwD certificates and Reservations?

Ans: Candidates are requested to submit the relevant certificates issued by the competent authority in the prescribed format of the Government of India. If the candidate fails to produce PwD/GEN-EWS/OBC-NCL/SC&ST certificate in the prescribed format, whichever is applicable, at the allotted ASU & H College, in that case, he/she will not be permitted to take admission. Further, if otherwise eligible, his/her category will be changed for seat allotment in the next round. Additionally, candidates are advised to read the Information Bulletin of the AIAPGET-2022 carefully, which is available at the following link: (https://aiapget.nta.nic.in/information-bulletin/)

Q.No.30. If I have a Birth Certificate/Caste Certificate/other certificates (s) in the regional language, will it be acceptable at the time of reporting/joining?

Ans: Certificates issued by the Competent Authority should be in English or Hindi. In case the certificate is issued in other than the English language, Candidates are advised to carry a certified (attested) Copy of the English version of the original certificate along with the original certificate, as most States insist on certificates issued in the English language.

Q.No.31. What can I do if there is a spelling discrepancy between the documents and the application form?

Ans: If there is a discrepancy in spelling in documents, the candidate must carry an affidavit/undertaking to prove that the documents belong to the same person.

Q.No.32. At the time of admission, will my original certificates be retained by the allotted college/institution?

Ans: Yes, all the participating colleges/institutions have been instructed to retain the original certificates of admitted students and release them only on the up-gradation of the seat or on withdrawal/cancellation of the seat by the candidate.

Q.No.33. Is it necessary to join the allotted ASU&H College to get a chance to participate in the 2^{nd} Round?

Ans: If the candidate is not interested in the 1st Round allotted seat, he/she can avail of free

exit without reporting/joining the allotted college. However, if he/she wants to hold the allotted seat in the 1st Round, he/she should join the allotted College physically and submit up-gradation willingness for the 2nd Round at the time of admission.

Q.No.34. Is it necessary to change the category (OBC-NCL/EWS) of the candidate to the UR category during admission if the candidate gets allotted a UR category seat?

Ans: No, there is no need to change the category (OBC-NCL/GEN-EWS) of the candidate to the UR category during admission if the candidate gets allotted a UR category seat.

IMPORTANT

Please note that, in case, you have joined the course/college allotted in the 1^{st} Round and not submitted the option for up-gradation in the 2^{nd} Round, you will not be considered eligible for up-gradation in the 2^{nd} Round.

Q.No.35. What happens the college/institute changes the category (e.g. OBC-NCL/EWS) of the candidate to the allotted category (UR) during admission if the candidate gets allotted a UR category seat?

Ans. If the college changes the category (e.g.OBC-NCL/EWS) of the candidate to the UR category during admission, the candidate will consider as UR candidate in subsequent rounds of counseling, and such candidates are not eligible for allotment of their category (OBC-NCL/EWS) seats. Hence, candidates are requested to ensure the same at the time of physical reporting at the allotted institute.

Q.No.36. I have submitted willingness for up-gradation in the 2nd Round while joining the 1st Round allotted seat. Later changed my decision and wanted to retain the 1st Round allotted seat; how can I avoid change/cancellation of already allotted college/seat of Round-1?

Ans: The candidate need not fill any fresh choices for the 2nd Round, so the earlier allotted seat (1st Round allotted) will be retained.

Q. No 37. What is the procedure for 2nd Round?

Ans: Fresh registration is available in the 2nd Round for candidates who have not registered in the 1st Round of Counseling.

Eligibility:

- > Freshly registered candidates
- ➤ Candidates who have availed free exit in the 1st Round
- ➤ Candidates who have joined in the 1st Round allotted seats and submitted willingness for up-gradation in the 2nd Round.

All eligible candidates, who desire to participate in the 2nd Round of online allotment, will have to submit fresh choices during the choice submission period and lock their choices during the locking period. All choices will be available, including newly added seats, vacant seats and virtual vacancies. Virtual vacancies are vacant seats which likely to get vacated during up-gradation. Eligible candidates will be allotted seats based on their merit and choices.

The choices of candidates who have joined in the 1st Round allotted seat and submitted willingness for up-gradation would be initialized (the choices remaining after allotment of seat in Round-1 will stands cancelled), and candidates are required to submit fresh choices for up-gradation to the 2nd Round. The Choices filled during the 1st Round will be treated as null & void.

Q.No.38. Who is eligible for the 2nd Round of allotment?

Ans: Candidates eligible for seat allotment in the 2nd Round would be from one of the following groups:

Group-I: Newly registered candidate for Round 2

Group-II: Registered candidates who did not get any seats in the 1st Round.

Group–III: Candidates who have reported at the allotted institute during 1st Round and submitted willingness for 2nd Round up-gradation as 'Yes'.

Group- IV: Candidates who have been allotted a seat in 1st Round but not Joined/ not Reported. (i.e., availed 'free exit')

Group V: Candidates who have resigned from the allotted seat of 1st Round before the commencement of the 2nd Round.

Q.No.39. Do I have to fill up the choice of courses and Colleges to participate in the 2^{nd} Round, 3^{rd} or Mop-up Round and Stray Vacancy Round of the online allotment process?

Ans: Yes, eligible candidates must submit fresh choice(s) of college(s)/course(s) for online seat allotment during the 2nd Round, 3rd/Mop-up Round and Stray Vacancy Round. In case a candidate does not fill in fresh choice(s) during the choice filling period, the candidate will not be considered for allotment of seat during the 2nd Round, 3rd / Mop-up Round and Stray Vacancy Round and will retain the earlier allotted (joined) seat if any.

IMPORTANT

It is necessary to fill in fresh choices in each Round of AACCC-PG counseling if candidate want to upgradehis/her admitted seats of previous round.

Q.No.40. Is it necessary to join Upgraded/allotted college If my allotted seat in the 1st Round gets upgraded in the 2nd Round?

Ans: Yes, In case the candidate is allotted a seat during the 2nd Round of the allotment process, the seat allotted during the 1st Round will automatically be cancelled immediately (i.e., allotted to somebody else), and the candidate should have to join the college/seat allotted during 2nd Round after obtaining online generated relieving letter through AACCC portal from the college allotted in the 1st Round.

If a candidate does not join the college/seat allotted during the 2nd Round, he /she can avail of free exit. Suppose a candidate joins the allotted/up-graded seat in the 2nd Round, in that case, he/she can exit with forfeiture of security money within the stipulated period (i.e., 3 days prior to commencement of 3rd/Mop-up Round). If the candidate fails to do so, he/she will become ineligible for further AYUSH-PG counseling. (Central/State/UT/Central Pool Quota.)

Seats can also be upgraded in the same college (same course) by change of category (i.e.ST/SC/OBC to UR or PwD to non-PwD); in such a case, the candidate has to take fresh admission on the upgraded seat, as per the procedure.

Q.No.41.What is the time period for the free exit for admitted candidates of the 1st Round?^M

Ans: A candidate who joined in the 1st Round allotted seat but has not been Upgraded in Round- 2 may resign his allotted seat of 1st Round within five days of Round-2 Result announcement, failing which he/she will be considered as joined candidate for Round-2 and rules of Round-2 will apply accordingly.

Similarly, Round 1 admitted candidates who have not submitted willingness for upgradation can also avail the free exit within five days of Round-2 Result announcement, if not do so he/she will be considered as joined candidate for Round-2 and rules of Round-2 will apply accordingly.

Q.No.42. I opted for up-gradation in the 2nd Round/3rd Round of counselling when reporting to the 1st Round/2nd Round allotted college. Will my earlier allotted seat (of first/second round) be cancelled?

Ans: Yes, once the seat is upgraded during the 2nd Round/ 3rd or Mop-up Round, the earlier allotted seat will automatically be cancelled, and the same will be allotted to another candidate.

Q.No.43. Can I join the college directly if my seat gets upgraded during the 2nd Round/3rd Round from the 1st Round/2nd Round of AACCC-PG counselling?

Ans: No, before you join the upgraded college/course, you will have to get an **online relieving letter** from the earlier allotted institute/college (of 1st/2nd Round), generated through the AACCC portal. The candidate will not be permitted to join the upgraded seats without the **online relieving letter** from the previous allotted colleges.

Q.No.44. If I get an upgraded seat but in the same college because of a change of category during $2^{nd}/3^{rd}$ or Mop-up Round(e.g. from SC/ST/OBC to UR category), do I have to take admission on the upgraded/allotted seat again?

Ans: Yes, you have to proceed as follows:

Step-1: Get an **online-generated relieving letter** through the AACCC portal from the institute for the earlier allotted seat.

Step-2: Join the upgraded category seat and get an online-generated **Provisional Admission Letter** through the AACCC portal for the upgraded category seat; otherwise, your earlier seat (previous round) would be cancelled and allotted to another candidate.

Q.No.45. Is it necessary to join the 2^{nd} Round allotted ASU&H College to participate in the 3^{rd} Round?

Ans: No, candidates need not report/join the 2nd Round allotted college to participate in the 3rd Round since there is an option of free exit.

However, suppose a candidate wants to hold the 2^{nd} Round allotted seat, in that case, he/she needs to join the college physically and give up-gradation willingness for the 3^{rd} /Mop-Up Round at the time of admission to the 2^{nd} Round allotted college.

Further, suppose a candidate wants to exit/withdraw from Round-2 joined institute/course; in that case, he/she will be allowed to withdraw the seat 3 days prior to the commencement of the 3rd Round with forfeiture of security money, then he/she will be eligible to participate in further AYUSH-PG counseling. If a candidate fails to do so, he/she shall become ineligible for further AYUSH-PG counseling (Central/ State /UT's/Central Pool Quota).

IMPORTANT

In case, candidates have not submitted willingness for up-gradation in the 3rd /Mop-up Round at the time of joining/reporting of 2nd Round allotted College, he/she will not be considered eligible for up- gradation in 3rd/Mop-up Round.

Q.No.46. If I joined the Round-2 allotted seat but later changed my decision and want to exit, then am I eligible to participate in further AYUSH-PG counseling (Central/State/UT/Central Pool Quota)?

Ans: Candidate needs to withdraw/surrender from respective institute 3 days prior to the commencement of 3rd/Mop-up Round with forfeiture of security money. If the candidate fails to do so, he/she shall be ineligible for further AYUSH-PG counseling (Central/State/UT/ Central Pool Quota).

Q.No.47. Am I eligible for further AYUSH-PG counseling if I resign from joined institute/course allotted in the 2nd Round?

Ans. Yes, the candidate shall be eligible for further AYUSH-PG counseling if he/she withdraws/surrenders from the institute/ course allotted in the 2nd Round 3 days prior to the commencement of Registration for the 3rd/Mop-up Round with forfeiture of security money.

Q.No.48. Who will be eligible for the "Exit with Forfeiture" option in the 2nd Round?

Ans: If a Candidate joined in the 2nd Round allotted seat and wants to exit within the stipulated period mentioned in the above **FAQ No. 47**, he/she may withdraw/surrender the seat with Forfeiture of Security Money.

Further, the candidate will become ineligible for any other AYUSH-PG counseling (Central/State/UT/Central Pool Quota) if he/she withdraws/surrenders beyond the permissible period (i.e., 3 days prior to the commencement of 3rd Round).

Q.No.49. I have registered in the 1st Round; should I register again for the 2nd Round & 3rd/Mop-Up Round?

Ans: No, candidates who have not registered in the 1^{st} Round need to register afresh for the $2^{nd}/3^{rd}$ or Mop-up Round.

Q.No.50. Can I withdraw/surrender the Round-2 admitted seat if I get allotted a seat through Central Pool Quota Counseling?

Ans. Suppose Round-2 admitted candidate is allotted a seat in the Central Pool Quota Counseling; in that case, he/she needs to withdraw/surrender the round-2 admitted seat 3 days before the commencement of the 3rd Round with Forfeiture of Security Money. If the candidate fails to do so, he/she shall be ineligible for Central Pool Quota counseling. Further, the AACCC, M/o Ayush has no role to play in the Counselling for Central Pool Quota seats.

Q.No.51. Who will be eligible for the 3rd /Mop-Up Round of AACCC-PG Counseling?

Ans: The Following categories of candidates are eligible for the 3rd/Mop-Up Round:

- a) Candidates who are registering for the first time.
- b) Registered candidates who have not been allotted any seat in Round 1 & Round 2.
- c) All candidates admitted in Round 1 or Round 2 and opted for up-gradation of their admitted seats (with fresh choice filling).
- d) Round 1 admitted Candidates availed of free exit options within the stipulated period.
- e) Candidate allotted seat in the 2nd Round and availed free exit (not joined/ not reported).
- f) Candidate withdraws from the 2nd Round allotted seat, 3 days prior to commencement of the 3rd Round, with forfeiture of Security Money (Need to remit the complete fees again).

Q.No.52. What is the procedure for the 3rd/Mop-Up Round of Counseling?

Ans: Fresh registration is available for candidates who have not registered in the 1^{st} Round/ 2^{nd} Round of Counselling. Further, those candidates who opted for up-gradation at the time of reporting to the $1^{st}/2^{nd}$ Round allotted institute/course may submit fresh Choices during the 3^{rd} Round choice filling period if they want up-gradation. The eligible candidates will be allotted seats on the basis of his/her choice and merit.

The seat matrix for vacant seats due to non-joining/vacating of the 2nd Round will be published on the AACCC portal. Candidates will be shown all available choices against actual and virtual vacancies. (Virtual vacancies are likely to be available when the seat gets vacated during up-gradation and during the seat conversion as per the following algorithm).

The AIQ (Govt. /Govt. Aided /CU/NI) seats that remain vacant after the 2nd Round will be converted during the 3rd /Mop-up Round of counselling as per the following algorithm, only if the reserved seat is not opted by any candidate/non-availability of candidate of that particular category in 3rd/Mop-up Round.

IMPORTANT

Candidates cannot claim Virtual vacancy seats. The Seat will be converted as per aforesaid algorithm, only if the reserved seat is not opted by any candidate/non-availability of candidate of that particular category during the 3rd/Mop-up Round. UR category candidates cannot claim the reserved seats shown to them as a virtual vacancy, if the same seat is opted by the candidate of that particular category.

Q.No.53. What will happen to vacant seats after the completion of the 3rd /Mop-up Round?

Ans: All India Quota seats of Govt. and Govt. aided/CU/NI institutions remain vacant after the last date for joining of 3rd/Mop-up Round will continue to be allotted during the online Stray Vacancy Round conducted by the AACCC, M/o Ayush.

The Vacant seats of Deemed University after the 3rd/Mop-Up Round of AACCC-PG counseling will revert to the respective Deemed University for conducting the Stray Vacancy Round at the institute level. AACCC, M/o Ayush will provide the list of eligible registered candidates for conducting the Stray Vacancy Round, which is to be strictly exercised as per merit during seat allotment.

Further, the list of ineligible candidates will also be circulated to concerned State/UT counseling authorities, National Institutes/ Central Universities/ Deemed Universities to prohibit them from participating in further AYUSH-PG counseling (Central/State/UT/Central Pool Quota..., etc.). (Please see the schedule on the website.)

Q.No.54. Is the Up-gradation allowed from the 2nd Round to the 3rd /Mop Up Round of the AACCC-PG counseling?

Ans: Yes, Up-gradation is allowed from the 2^{nd} Round to the 3^{rd} /Mop-up round. However, the candidates must take admission on their upgraded seats in the 3^{rd} / Mop-Up Round from the 1^{st} / 2^{nd} Round admitted seats. If such candidates do not join the upgraded seats, their security money will be forfeited, and they will become ineligible for further AYUSH-PG counseling. (Central/State/UT/Central Pool Quota).

Q.No.55. Should I be eligible for State/UT/Central Pool Quota Counseling if I am allotted/upgraded a seat in the 3rd Round of AACCC-PG counseling?

Ans: No, if a candidate has been allotted/upgraded a seat in the 3rd/ Mop-up Round, he/she must join the allotted institute within the stipulated time and will not be eligible for further AYUSH-PG Counseling.

Q.No.56. What will happen if a candidate does not join the 3rd Round allotted institute?

Q.No.57: Who is Eligible for Stray Vacancy Round?

Ans: All registered candidates not holding any PG seats allotted through previous Rounds of AACCC-PG counseling or counseling conducted by State/UTs, are eligible for Stray Vacancy Round. However, Candidates are advised to confirm their eligibility conditions before applying.

Ans. No new registration is available in the Stray Vacancy Round of AACCC- PG counseling-2022.

Q.No.59: Should I submit any willingness to participate in the Stray Vacancy Round?

Ans. Candidates must submit a willingness in the AACCC-PG portal to participate in the Stray Vacancy Round with an undertaking that they are not holding any PG(ASU&H) seats allotted through AACCC-PG counseling or counseling conducted by State/UTs.

Q.No.60: Who is ineligible for the Stray Vacancy Round of the AACCC-PG Counseling?

Ans:

1) Candidates who already joined the allotted seat in Round 1/Round 2/3rdor Mop-Up Round of AACCC-PG counseling at AIQ/ Deemed/ Central Universities/National Institutions.

- 2) Candidates allotted a seat in the 3rd/Mop Up Round.
 - 3) Candidates who have not registered in any of the Previous 3 Rounds.
 - 4) Candidates who resigned from the allotted seats in the 2nd Round beyond the permissible period of exit (i.e., 3 days prior to the commencement of the 3rd Round).

Q.No.61. Is the choice-filling facility available in the Stray vacancy round of AACCC-PG counseling?

Ans. Yes, the choice-filling facility is available in the Stray vacancy round of AACCC-PG counseling.

Q.No.62. Is there any Up-gradation allowed from the 3rd Round to the Stray Vacancy Round of the AACCC-PG counseling?

Ans: No, Up-gradation is not allowed from the 3rd Round to the Stray Vacancy Round of the AACCC-PG counseling.

Q.No.63. Should I be eligible for State/UT/ Central Pool Quota Counseling if I am allotted a seat in the Stray Vacancy Round of the AACCC-PG counseling?

Ans: No, if a candidate has been allotted a seat in the Stray Vacancy Round, he/she will not be eligible for further AYUSH-PG Counseling.

Further, the candidates must take admission on their allotted seats in the Stray Vacancy Round. If such candidates do not join the allotted seats, their security money will be forfeited, and they will become ineligible for further AYUSH-PG counseling. (Central/State/UT/Central Pool Quota)

The names of all ineligible candidates will be circulated to all Central/State counseling authorities to prohibit them from participating in any other AYUSH-PG counseling.

Q.No.64. What will happen if I am not joined the seat allotted through the Stray Vacancy Round of the AACCC-PG counseling?

Ans: Candidate must join the seat allotted through the Stray Vacancy Round; otherwise, he/she will become ineligible for further AYUSH-PG counseling. (Central/State/UT/Central Pool Quota). Further, the refundable security amount will be forfeited

Q.No.65. Should the Security Fees be refunded if a candidate is not allotted a seat in all four (1st/2nd/3rd or mop-up/Stray vacancy) Rounds of AACCC-PG counseling?

Ans: Yes, if the candidate is not allotted any seat during AACCC-PG counseling, the

Security Fees will be refunded to the bank account provided by the candidate at the time of registration in the AACCC-PG counseling.

Q.No.66. Who is eligible for the Stray Vacancy Round conducted by Deemed Universities?

Ans. Only candidates registered in the AACCC-PG counseling are eligible to participate in the Stray Vacancy Round Conducted by respective Deemed Universities. The list of such candidates will be forwarded to the respective Deemed Universities for conducting Stray Vacancy Round. The AIAPGET-2022 qualified Candidates who are not registered on the AACCC-PG portal are not eligible for the Stray Vacancy Round conducted by Deemed Universities.

Q.No.67: What will be the eligibility criteria for admission to 50% Institutional Quota seats of Banaras Hindu University (BHU), as the AACCC, M/o Ayush conduct the counseling for the same?

Ans: The eligibility conditions for admission to 50% Institutional Quota seats of the Banaras Hindu University (BHU) will be as per the eligibility criteria given by the respective University at the time of counseling. For additional information, please contact the concerned Universities.

Q.No.68: Whether there will be separate counselling for AIQ seats and 50% Institutional Quota seats of BHU, on separate days and separate platform?

Ans: No, there is a common counseling software for AIQ of Govt./Govt. aided/ Central University/ National Institutes/Deemed Universities as well as for 50% Institutional Quota seats of Banaras Hindu University (BHU). Hence, those candidates, who are eligible for 50% Institutional Quota seats of Banaras Hindu University (BHU), should opt the choices in order of preference between AIQ and 50% Institutional Quota seats of Banaras Hindu University (BHU). The computer software will allot the seat in order of choice and merit of the candidate. It is important to note that preference should be given to the Internal/Institutional candidates as per the eligibility criteria provided by the respective University for the current academic year.

CHAPTER-6 REGISTRATION FEE & SECURITY MONEY

FEES RELATED FAQ's

Q.No.1. What are the various fees to be paid at the time of registration?

Ans: At the time of registration, students must pay two kinds of fee

- a) Non-Refundable Registration fee
 - ➤ For admission to AIQG-college/AIQGA-college/National Institute/ Central University:
 - For UR/EWS/OBC candidates- Rs.2000/-.
 - For SC/ST/PWD candidates- Rs.1000/-.
 - For Deemed University- Rs.5000/-
- b) Refundable Security Fee- It will be refunded to candidates after joining the allotted college in the stipulated time mentioned in the schedule or if candidate did not get any seat during all rounds counseling, to the bank account provided by the candidate at the time of registration for AACCC-PG counseling.

- For admission to AIQG-college/AIQGA-college/National Institute/ Central University:
 - For UR/EWS/OBC candidates—Rs.10,000/-
 - For SC/ST/ PWD –Rs. 10,000/-
- ➤ For admission in Deemed University -Rs. 50,000/-For example:

Conditions:

- Any candidate opting for Deemed University will have to pay an amount of Rs.55000/- at the time of registration (i.e.,Rs 5000/- Non-Refundable Registration fee + Rs. 50,000/-Refundable Security fee.)
- 2. Any SC candidate opting for AIQG seat only will have to payan amount of Rs.11000/- at the time of registration (i.e., Rs 1000/- Non-Refundable Registration fee + Rs. 10,000/- refundable Security fee.)

Q. No. 2: If candidate wish to apply for both AIQ and Deemed University, he/she need to payfee for both?

Ans: No, in such case, the candidate has to pay only the higher fee, i.e. of DeemedUniversity Rs. 5000/- (Registration fee) plus Rs. 50,000/- (security money).

Q.No.3: What is the norms for the forfeiture of security money during AACCC-PG counseling?

Ans. If the candidate is not eligible for refund of security money due to non-compliance of counseling scheme, the full security money will be forfeited irrespective of the category (e.g. AIQG or Deemed University) of the seat allotted.

REFUND RELATED FAQs

Q.No.1. When will the Refundable security amount be refunded if I am eligibleas per the Refund Policy?

Ans. Refund will be initiated only after completion of all rounds of AACCC–PG Counseling.

Q.No.2. When and where the Security amount will be refunded?

Ans:

- a) Security amount will be refunded only after 20 working days from the date of publication of the refund list by AACCC on its website (www.aaccc.gov.in)
- b) The security amount will be refunded to the Bank Account provided by the candidate at the time of online registration on the AACCC portal, i.e. www.aaccc.gov.in
- c) The Candidates are advised to upload a clear legible scanned image/copy of the front page of the Bank passbook/cancelled bank cheque/ Bank e-Statement (having account details) during the registration on the AACCC portal.
- d) The candidates are advised to keep their bank account active till the refund process is completed.

Q.No.3. What happens if the candidate, by mistake, makes more than one payment for the same Roll #?

Ans: Candidate can approach the Financial Custodian after 15 days of closing of Registration Window. The Financial custodian will refund the excess payment, if any, within 30 days of receipt request from the candidate.

Q.No.4. Do I have to request the Financial Custodian to refund the security amount? What is the schedule for refund of security amount?

Ans:

- a) NO. Candidate need not approach the Financial Custodian for refund of security amount.
- b) The AACCC, M/o Ayush will publish the list of candidates who are eligible for the

- refund of security amount in the AACCC website (www.aaccc.gov.in) as and when the counseling process is completed (all rounds of counseling are completed). The Financial Custodian will complete the refund of security amount within 20 working days of publishing the eligible list in the AACCC Website.
 - c) Once the Financial Custodian completes the refund, AACCC, M/o Ayush will publish the refund details along with refund date & transaction # in the website of AACCC (www.aaccc.gov.in). The refund will be credited, depending upon the level of digitalization of candidate's bank, to the candidates account between 02 to 15 days from the date of refund by Financial Custodian.

Q.No.5. Can I initiate refund proceedings through chargeback claim through the card issuing bank?

Ans: No, Candidates who have been allotted seats should not initiate refund proceedings through chargeback claim through the card issuing bank. If the charge back claim is initiated, the Financial Custodian will not be in a position to initiate direct refund and thereby refund of security amount will be delayed.

Q.No.6.Who is the Financial Custodian?

Ans: All India Institute of Ayurveda (AIIA), New Delhi, an autonomous institute under the Ministry of Ayush is the Financial Custodian for AACCC-PG counseling-2022. They will, on behalf of AACCC, M/o Ayush, collect non-refundable Registration Fees and refundable security amount from the candidates and refund the security amount, on the advice of AACCC, to the candidates.

Q.No.7. How to contact the Financial Custodian?

Ans: The candidate can contact Financial Custodian (finance-aaccc@aiia.gov.in) through registered mail id.

- a) Direct queries to AACCC, M/o Ayush regarding payment /refund will not be entertained.
- b) Financial custodian will entertain only payment and refund related queries through <u>finance-aaccc@aiia.gov.in</u>
- c) For other than financial related queries, the candidates may contact AACCC through mail counseling-aaccc@aiia.gov.in

Q.No.8. Will AACCC, M/o Ayush bears the bank charges incurred by the candidate while registering for counseling?

Ans: No, Bank Charges, if any, incurred by the candidates should be borne by themselves.

Q.No.9.Will the AACCC, M/o Ayush pays interest in the refundable securityamount?

Ans: No, AACCC M/o Ayush will not pay interest on the refundable security amount.

Q.No.10. Can candidate remit the Registration Fee and Security Deposit from NRI Account?

Ans: No, since AACCC, M/o Ayush cannot, as per Reserve Bank of India (RBI) Rules, refund security deposit to NRI Account. If the candidate wants to use the funds available in his/ her NRI Account for registering for counseling, he/ she has to first transfer funds from NRI Account to NRO Account and from NRO Account to AACCC. Further, the fund from AACCC will be credited to NRO Account only.

Q.No.11. If the candidate does not get payment confirmation from payment gateway provider, whom he/she should approach for payment confirmation?

Ans: The candidate should approach the Financial Custodian, who will respond within 5 bank working days of closing of Registration window.

Q.No.12. Is this Security fee refundable in all the cases?

Ans: No, in the following cases Security Money shall be forfeited:

- a) Round 1 admitted candidate (upgraded/not upgraded) who withdraws his/her seat after the stipulated period mentioned in the counseling scheme (i.e., after five days of the publication of the result of Round 2)
- b) If the candidate withdraws/surrenders the allotted seat during 2nd Round.
- c) If the candidate has not reported/not joined the allotted/upgraded seat through the 3rd /Mop-up Round/ Stray Vacancy Round.
- d) If the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting.
